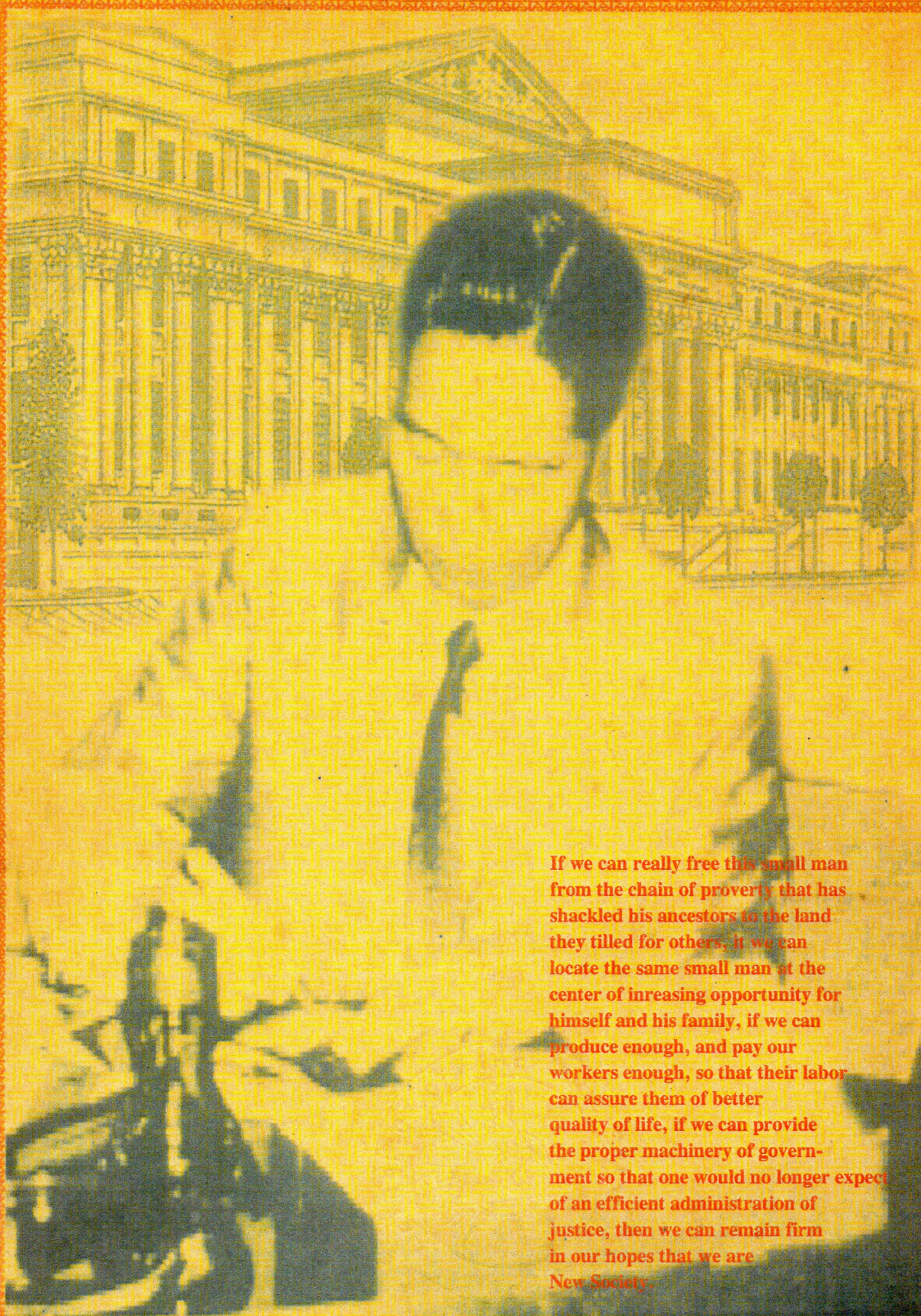

LETTER OF INSTRUCTION  
for the

*"Ang Bagong Lipunan Peso Bills or Philippine Currency printed by the Central Bank of the Philippines - under the Central Bank Law, R.A. No. 265 known as the "Managers Paper Currency System" as per instruction of His Excellency Ferdinand Edralin Marcos, in line with the new spirit of Dynamic Nationalism that animates the New Society, for peace, development and prosperity of all filipinos. The ABL currency printed with back up guarantee deposit of gold, platinum and diamonds quantified the volume in metric tons and karats, insured in various insurance in Lloyd's of London and other Bank of International Commercial Trust and Obligations assured by the "Fund Committee of the World", universally recognized by major financing institutions, led by the World Bank and International Monetary Fund (IMF) covered by pass code numbers.*

*I, Ferdinand E. Marcos, President of the Republic of the Philippines by virtue of the powers vested in me by the Constitution as Commander in Chief of the Armed Forces of the Philippines and pursuant to proclamation No. 1081 dated September 21, 1972 and General Order No. 1 dated September 22, 1972 as amended, do hereby authorize and instruct the Central Bank and Department of Finance in printing the "Ang Bagong Lipunan" Monetary Currency to augment the Development Programs of the government in order to effect the desired changes and reforms in the social, Economic and Political Structures of our country, intended to National Development, especially the countryside, for the benefit of the Filipino masses, for our vision of Philippines 2000 and beyond as my immortal legacy to my beloved*

*In effect, in order to facilitate the implementation of the program or reforms in government and to speed up the current intensified efforts for social programs, broadening of social services to the people, productive life and for equal share in benefits of progress, I do hereby direct all appropriate principal proponents and key players of the implementation of the Master Plan for Progressive of redemption as embodied in the certificate of entitlement, special trust agreement of different allied states and observing the maturity date of the different precious metals guarantee deposit that back up the printing of "Ang Bagong Lipunan" currency.*
